Subject: Filling up of the post of Deputy Director General (DDG) in the Narcotics Control Bureau (NCB) under the Ministry of Home Affairs on deputation basis: Regarding

The undersigned is directed to say that it has been proposed to fill up 02 (two) future vacant posts of Deputy Director General in the Narcotics Control Bureau, under the Ministry of Home Affairs on deputation basis. The number of vacancies is subject to change/variation. The post is in the Pre-revised scale of Pay of 18,400-500-22400. The terms and conditions of deputation will be governed by the Department of Personnel & Training in OM No. No.6/8/2009-Estt. (Pay II) dated 17.06.2010, as amended from time to time. The period of deputation, including deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization/Department of the Central Government, shall ordinarily not exceed 5 (five) years. The maximum age for appointment on deputation shall not exceed 56 years, as on the closing date of receipt of application.

  - (b) Cadre Clearance incorporating that in the event of his/her selection, he/she will be relieved to join the Post of Dy.Director General in Narcotics Control Bureau on deputation basis.

- (c) Vigilance Clearance
- (d) Integrity Certificate.
- (e) A certificate to the effect that no major/minor penalty has been imposed upon the candidate during the last ten years.

4. It may also be noted that in the event of selection, the concerned officer will not be permitted to withdraw his candidature.
